1. KIOCL Limited issued online e-Procurement System open tender vide notification ref. No. KIOCL/TS/7130/F-519/514 dated 13.03.2020 for carrying out the clearing of spillage materials and housekeeping in Ball Mill Grinding System under annual contract at the Filter Plant of Port Facilities Department, Pellet Plant Unit, KIOCL Limited, Panambur, Mangalore. In response to the above open tender enquiry, you have submitted the offer and KIOCL has also received offers from other 3 bidders. As per the prequalification of the tender bidder has to submit highest value of similar nature of work executed in any single year during last 7 years and minimum required was 3 similar completed works costing is not less than Rs. 20.88 Lakhs or 2 similar works costing not less than Rs. 26.10 lakhs or one similar completed works costing not less than Rs. 41.77 Lakhs.
2. The technical bids were opened on 12.05.2020 and the same was evaluated. Price bids were opened on 26.05.2020.
3. Technical services department of KIOCL Limited received anonymous telephone call and message stating that document submitted by M/s. Fivestar Facilities Solutions India Private Ltd viz service agreement and work completion certificate and other documents are not original and genuine.
4. KIOCL has verified the document submitted by you for fulfillment of pre-qualification criteria i.e work completion certificate issued by M/s. Bulldyers Protection Pvt Ltd dated 10.05.2020. However, it is found that over telephone enquiry (Ph.no. 0522-4107970) information received that M/s. Bulldyers Protection Pvt Ltd was existing up to 2015 and at present company is not existing. But you have submitted the work completion certificate dated 10.05.2020 stating that providing services since 2013 to till date which shows that the said letter is not genuine and if the said company is not existing at present it will not issue such a

letter. You have also submitted the certificate of incorporation dated 10.08.2015 and PAN Number also dated 10.08.2015 and other documents relating to your Company also for 2015. Another agreement copy submitted by you is dated 26.06.2015 which is also prior to the incorporation to the Company.

KIOCL had issued show cause notice vide no. KIOCL/TS/F-519/1213 dated 08.07.2020 advised to submit your reply to this show cause notice along with supporting documents and documentary evidence which you wish to rely in support of your reply within 15 days from the date of receipt of this notice.

We have cancelled your participation for the tender enquiry KIOCL/TS/7130/F-519/514 dated 13.03.2020 for not providing the clarification sought. Till today KIOCL has not received any reply against our mail dated 09.07.2020 & 29.07.2020

In view of the above, KIOCL Limited hereby ban your firm/company from participating in the future tenders and contracts of KIOCL Limited for a period of three (3) years.
